CONSTRUCTION OF GOVENDER ACCESS ROAD – EARTHWORKS, SURFACING AND SAFETY IMPROVEMENTS (KM 0.00 – KM 0.632).

Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to www.dubetradeport.co.za for more information on DTPC.

DTPC wishes to appoint a competent contractor who is registered with, and have active CIDB grading of **3CE or 4CE only** for the construction of Govender access road – earthworks, surfacing and safety improvements (km 0.00 – km 0.632).

The works include, but are not limited to, earthworks, importing and compaction of road layer works, asphalt surfacing, and construction of concrete lined v-drains and installation of pipe crossings.

It is a condition of tender that **only African black female owned companies** are eligible to tender for this project. Only bidders who are registered and have an active CIDB grading of **3CE or 4CE will be eligible to tender**.

EVALUATION OF THIS BID

All proposals will be evaluated in various stages: Compliance and functionality will be assessed first, and thereafter prices and preference points for all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2017 using the 80/20 preference point system.
