Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to www.dubetradeport.co.za for more information on DTPC.

Dube TradePort invites proposals from suitably qualified, experienced and independent professional service provider to support the fibre network for a period of three (3) years. These services will include but not limited to:

- Provision of installation services for new fibre installation on an ad hoc basis
- Provision of repairs and maintenance services on an ad hoc basis
- Provision of hardware and software warranties from Dasan Zhone for GPON equipment
- Provision of additional Dasan Zhone equipment on an ad hoc basis

In line with the PPPFA regulations, 2017 sub reg. 4(1) (c) (i), the prequalification criteria for this bid is that **only** tenderers subcontracting a minimum of 30% to an EME or QSE which is at least 51% owned by black people shall be eligible to tender.

EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2017 using the 80/20 preference points system.
