The successful bidder will be required to provide waste management services for all waste streams including but not limited to recyclables, non-recyclables, hazardous waste and general waste for specified areas within the precinct viz. buildings, infrastructure, facilities and grounds.

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2011 using the 90/10 procurement procedure.
